## 2014 BALD EAGLE CREEK TROUT TOURNAMENT

Welcome to the 16th Annual 2014 Bald Eagle Creek Trout Tournament. The Tournament is scheduled for April 19th and 20th. To qualify for cash prizes, a tournament donation is required. (see registration form for amount and deadlines).

**New !** - Any 2014 BECTT registered fisherman catching a prior year BECTT tagged trout during the event will receive a \$25.00 cash payout. Fish must be brought in to check-in station in live condition per tournament rules to qualify.

**New ! - Community Trout** – New for 2014. The cost to participate is \$1.00 per registered fisherman and you must enter this contest prior to the start of the tournament. One of the tagged trout will be randomly chosen to be the Community Trout. If the chosen tagged trout is caught, the fisherman will receive 100% of the money collected if he/she is participating in this contest. If the community trout is caught by someone not participating in this contest, the fisherman will receive the value of the tagged trout only. If the community trout is not caught or is caught by a non-participating fisherman, the tournament committee will keep one-half of the money and the other half will be rolled over to the next year.

**Change** - 200 Bonus BECTT Tagged Trout – Will be stocked on Saturday afternoon (previously stocked on Saturday evening) to allow fishermen more time to catch these fish during the tournament.

**Change** – Fishing times – Saturday added an hour and Sunday eliminated an hour.

In 2013, we had a total of 768 Tagged Trout valued at over \$18,000. Prizes range from \$10 to \$1,000.

Total prize payout was \$12,045

*Proceeds from this event directly benefit the Bald Eagle Sportsmen's Club, Inc.*

### Big Trout Contest

All registered fisherman may also elect to participate in the Big Trout Contest. To be eligible, each participant must contribute an additional \$10.00 prior to the start of the tournament. The qualified participant catching the largest tagged trout (2014 BECTT Tags) will not only receive the sponsored amount for the trout caught, but will also receive a Trophy and a large percentage of the funds collected for the Big Trout Contest. AGAIN FOR 2014 - Additional place winners in the contest will receive cash awards as well. The trout must be checked-in to the Headquarters in live condition as determined by Tournament Judges. The winners will be determined by the length of tagged trout. Total Big Trout payout will be 50% of what is brought in. The total Big Trout payout in 2013 was \$1,640. Multiple Winners!.

We will again be offering free camping at the Port Matilda Community Park. Camping will be on a first come-first serve basis. There is limited room for campers, while tenting space is unlimited. **Camper's must register at the entrance to the community park.** No Alcoholic Beverages are permitted in the park. **CAMPING ALONG THE STREAM WILL NOT BE PERMITTED.** The stream will be patrolled beginning Friday and continuing through the end of the tournament.

The Port Matilda Sportsmen's Club will be our food service vendor again for this year's tournament. Please help support their fundraising efforts as well. They are planning a breakfast on Saturday & Sunday morning starting at 4:00 a.m. and will be providing food services all weekend including Friday evening at the Port Matilda Sportsmen's Club. Our Bait Vendor will be Yingling's Bait Hut (814)742-9259 from Bellwood, PA.

You may pick up your badge at the Port Matilda Sportsmen's Club from 3:00 p.m. to 9:00 p.m. on Friday April 18, 2014 or any time after 4:00 a.m. on Saturday April 19, 2014. **Please remember you must pick up your badge before participating in the Tournament.** We will not be mailing the badges to you.

Fisherman under the age of 16 must be accompanied by a parent or guardian, and/or have written permission to participate in this event.

As part of this brochure you will find the registration form for this year's Tournament. Please read the rules & liability waiver carefully before completing. Make checks payable to the Bald Eagle Creek Trout Tournament. If you have not registered by the April 7th pre-registration deadline, please bring your completed application with you on Friday afternoon or whenever you decide to register.

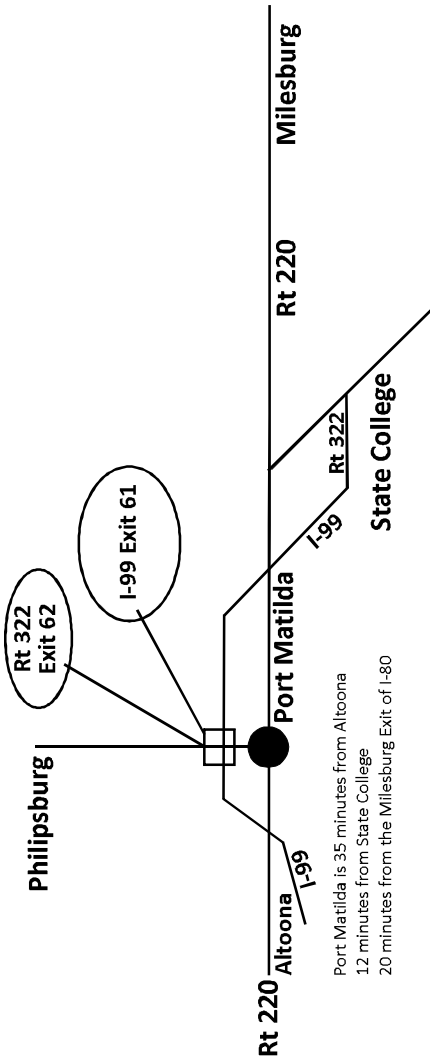

## RULES

- Each participant must be properly registered, must display official tournament registration button, and if over 15 years of age, must possess a valid PA State Fishing License. All PA Fish & Boat Commission Rules Apply.
- Fish must be presented at the check-in station in LIVE CONDITION as determined by tournament judges. This includes fish that may qualify for the Big Trout Contest. All judge's decisions are final.
- All fish must be legally and fairly caught. No lifting, snagging, or net line permissible.
- Only fish caught by registered participants are eligible for prizes.
- Entrants may begin fishing Saturday at 6:00 a.m. and must stop fishing by 8:00 p.m. with the check-in stations open from 6:00 a.m. to 8:30 p.m. Entrants may begin fishing on Sunday at 6:00 a.m. and must stop fishing by 3:00 p.m. with the check-in station open from 6:00 a.m. to 3:30 p.m. No fish will be accepted after the closing times.
- Any individual found in violation of the rules will be disqualified.
- Respect property owner's rights. Stay off posted lands and clean up after yourselves.
- The sponsors of this tournament encourage catch and release so others may enjoy fishing in this area.
- All prize money must be claimed prior to the end of the tournament.

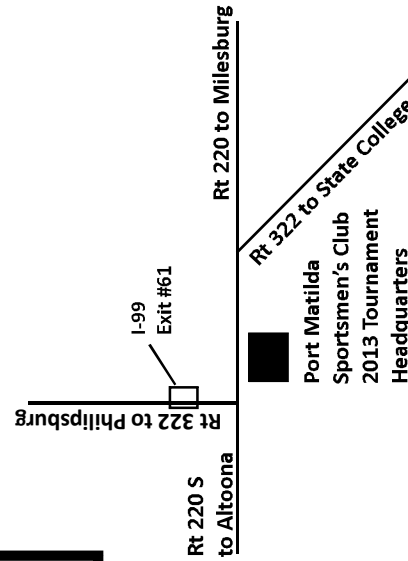
